is a traditional choice for shading the louver option provides the ultimate in sun control as each section can be adjusted for optimal light control. For areas that receive measurable snow fall, the lattice sections require removal for the winter. With the louver option, the slats can be vertically positioned and left in place throughout the year. There are three color choices—Deep Red, Coastal Gray and Espresso.
